# 01 OurHistory

TOP Electronic Components S.A, has been present in the Greek and global market for about 30 years. It was founded in 1993 after the merging of the three private companies, under the names of I. POULOS & CO., P. TOUMPIS & CO. and A. TSAGKOGEORGAS & CO., which were already operating in the Greek market since 1973.

This consolidation enabled the structural re-organization of the company and led to the enhancement of customers' support and acceleration of growth. The continuous progress of the company, made the need for facility expansion evident, so by 1997, the com-



pany had already relocated to its new premises, a private-owned building, located in a strategically selected region between the center of Athens and the busy port of Piraeus. With a total area of 4600m2 of offices and warehouses, the new HQ hosted effectively the organization until 2014, when an additional warehouse of 2700m² was acquired, significantly increasing the storage capacity of the company. This location and space investment, resulted in a higher level of customers' satisfaction by providing them easier access to the companies services.

During these years, TOP, driven by a customer-centric orientation and a thoughtful financial management, managed to acquire several widely recognized certifications. As a reward for its efforts and commitment to high quality services, in 2011 the company entered the list of the Strongest Companies in Greece [issued originally by ICAP and later, until today, by the International Duns & Bradstreet organization located in the US].

It was at the same period that the company decided to also invest in the development of **a website** along with a functional B2B e-commerce platform [www.topelcom.gr] which was widely accepted by its customers and brought new potential to the everyday business.

Throughout the years and up to the present day, having come across and successfully overcome critical periods caused by both the country's and global instability, TOP has managed to develop and maintain an on-going competitive advantage, regarding prices in offer and quick delivery solutions for non-stocked items, all adding up to an efficient customer service. Moreover, it operates in an environment that constantly guarantees technologically updated products resulting from the company's know-how in the wholesale trade sector. 


